The specification and documentation approach builds upon precise behavioral specification of interfaces using the trace function method (TFM). It also introduces a number of structure functions or connection documents. These functions capture both the static and dynamic behaviors of component based software systems. They are used as a basis for a novel document driven structure based reliability prediction model. System reliability assessment is studied in at least three levels: component reliability, which is assumed to be known; interaction reliability, a novel approach to studying software reliability; and service reliability, whose

estimation is the primary objective of reliability assessment. System reliability can be expressed as a function of service reliability. A mobile streaming system, designed and developed by the author as an industrial product, is used as a case study to demonstrate the application of the approach.
